1. To receive and approve the minutes of the last AGM, to consider matters arising
2. To receive, consider and, if approved, adopt the Annual Reports of the Chairperson, Secretary, and Secretaries of Sub-Committees of the Association.
3. To receive, consider and, if approved, adopt the Annual Report of the Treasurer and the Financial Statement of the Association as confirmed by the Auditor.
4. To appoint an Auditor.

## Notes

The constitution states:

- A General Meeting of the Association shall be held annually not earlier than March 1<sup>st</sup> nor later than April 30<sup>th</sup>.
- The Secretary shall give affiliated Clubs, together with all members of the Executive elected in accordance with clauses (a), (b) and (c) of Rule #5, at least 14 days notice convening the General Meeting and giving the agenda of business to be conducted at such General Meeting.
- The President, or in their absence or at their wish, the Chairperson of the Executive, shall chair the General Meeting. In the absence of President, Chairperson and Vice-Chairperson, the Meeting shall be chaired by a person as agreed by the attendees.
- Each Club affiliated to the Association shall be entitled to send representatives as follows to any General Meeting, each of whom shall be entitled to vote:-
  - (i) Clubs paying the full subscription = 2 representatives.
  - (ii) Clubs paying the reduced subscription = 1 representative.
- The President, Officers and other Officials of the Association as per clauses (a), (b) and (c) of Rule #5 shall be entitled to attend and vote at any General Meeting, together with any Life Vice-Presidents elected in accordance with Rule #8 (f).
- Voting shall be confined to those present and entitled to vote and shall be by show of hands, unless a ballot is demanded by not less than five voting attendees. In the event of a tied vote, the Chair of the Meeting shall have a casting (extra) vote. In the event of a ballot being demanded the Meeting shall elect two members to supervise and count the votes cast and such members shall then report the result of the ballot to the Chair. No person shall have the right to use a proxy vote.
- A simple majority shall determine any matter except for a proposal for alteration of the Constitution. Such alteration requires agreement of at least two-thirds of those present and entitled to vote. (*Refer to Rule #15.*)
- No business shall be transacted at any General Meeting unless a quorum is present when the Meeting proceeds to business. The quorum shall be eight members present and entitled to vote.
